Except for the essential services, all services and sectors has been shut temporarily. This has created a financial turmoil and economic crisis in the financial market of Nepal. To provide interim relief, GON on date 2076-12-16 (29-Mar-2020) declared several relief measures. This is an attempt by CLA to list the important relief measures declared by the GON in simple yet informative way.

Relief for Workers/Employees/Employers	
Relief for Employee	Employer shall provide remuneration/salaries to its employees.
	Entities related with Tourism sector shall provide full remuneration
	to its employees working on daily wage basis or monthly basis for
	the month of <i>Chaitra</i> 2076.
Relief for Employer	Entities can utilize the amount deposited in its Welfare Fund to pay
	remuneration/salary to its employees until the business resumes.

Waiver in Late Fee	To waive fines or any additional cost for delay in submission of the
	utility bills of electricity, water, telephone and internet for the



	months of Falgun and Chaitra 2077 Baisakh, if paid by Baisakh

NEA Incentive for Manufacturers	For all electricity in reserve due to high production than demand –	
	NEA shall provide a discount of 30% to 50% (depending on the	
	nature) to all manufacturing industries that utilizes the reserved	
	electricity within stipulated time.	
Incentive on Loans of EPF and CIT	Employee Provident Fund and Citizens Investment Trust shall	
	extend repayment dates on interest and loan amount till Baisakh	
	2077 and shall arrange to provide discount in the interest rates.	
Incentive to Farmers and Food	- To arrange for the transportation of milk, vegetables,

Relief on Rent and Rent Tax	Landlords and houseowners to facilitate by waiving one-month	
	rent of non-institutional tenants. GON shall arrange to waive rent	
	tax for such waived rent.	
	Relief on Custom Duty	
Waiver in Custom Duty	GON has waived all custom duty charges on the import of medical	
	equipment and medicine essential for the prevention and control	
	of COVID-19.	
Partial waiver in Custom Duty	In addition to the medical equipment, GON has also provided	
	partial waiver of Custom Duty while importing Facemasks, hand	
	sanitizer and Induction stove.
